- (5) Application Procedure: The application form must be completed and submitted together with the supporting documents listed below **BEFORE** the closing date.  - C) A photocopy of birth certificate.
- (6) Appraisal & notice: All applications shall be appraised and approved by the Study Award Sub-Committee. All applicants shall be informed in writing of the status of their applications, and the result of application is to be announced onto the Association's official website.
- (7) Award Giving Ceremony . Successful applicants must be presence with proper school attire on the day of Study Award Giving Ceremony.

 Those who are unable to attend shall give a written consent and appoint representative (with name and I.C number) to the Secretariat PRIOR to the ceremony.
- (8) Unclaimed Award: All awards must be collected within a month from the date of Award Giving Ceremony, failing which the Award will be forfeited.
- (9) Deliberation: In the event of any dispute, the Board of Association Committee deserves the right to discuss and decide, and its' decision shall be final.
- (10) The Study Award Sub-Committee deserves the right to alter any of the term and conditions stated. But the final approval shall be obtained from the Board of Association Committee prior to reinforcement.
